Required education: Higher education – specialized in the field Required documents:

- Leading the orchestra
- Leading the first violin section
- Bowings

- Consulting on personnel with section leaders
- Collaborating with the conductor
- Consulting on musical issues
- Managing sectional rehearsals
- Representing the orchestra in artistic matters
- Membership in the Artistic Council advisory body to the General Director of the W-M Philharmonic Participating in rehearsals, concerts, and recording sessions (phonographic, radio, and television)
- Individual preparation before the first rehearsal Maintaining personal artistic development Participating in courses/workshops Maintaining the image of the Warmia-Mazury Philharmonic.

Position requirements: Availability Ability to work in a team High personal culture Professional experience

Please attach an audio-video recording of your performance of one or more of the following pieces to your application:

1. A Classical piece
2. A Romantic piece
3. A 20th century repertoire piece

The recording should be made in its entirety, without editing, and submitted via a link to a streaming service (YouTube etc.)

Selected candidates will be notified individually about admission to the audition by August 15, 2025

- Violin Concerto W.A. Mozart No. 4 KV 218 or No. 5 KV 219 – movement 1 (Exposition, without repeats, with cadenza) and movement 2

- Violin Concerto by Czajkowski, Brahms, Beethoven or Sibelius – movement – only part 1

Auditions will take place on September 8-9, 2025 at 10:00 AM.

An accompanist will be provided by the Philharmonic.
